TOWNSHIP OF TEANECK BERGEN COUNTY, NEW JERSEY ORDINANCE NO. 3881

AN ORDINANCE AMENDING CHAPTER 19 ENTITLED "GARBAGE AND REFUSE" OF THE TOWNSHIP CODE.

BE IT ORDAINED by the Township Council of the Township of Teaneck, Bergen County, as follows:

SECTION 1. That Article I "In General", Section 19-1, "Definitions" be hereby amended as follows:

Add:

Litter. Any used or unconsumed substance or waste material which has been discarded, whether made of aluminum, glass, plastic, rubber, paper, or other natural or synthetic material, or any combination thereof, including but not limited to any bottle, jar or can, or any top, cap or detachable tab of any bottle, jar, or can, any unlighted cigarette, cigar, match, ash, or any flaming or glowing material or any garbage, trash, refuse, debris, rubbish, grass clipping, dirt, or other lawn or garden waste, newspapers, magazines, glass, metal, plastic or paper containers or other packaging or construction material, but does not include the waste of the primary processes of mining or other extraction processes, logging, sawmilling, farming, or manufacturing. Material placed as part of other Township approved programs, such as recyclable pickup, leaf removal, and garden debris removal are not considered part of this definition.

Litter Receptacle. A container suitable for the depositing of litter.

Person. Any individual, corporation, company, partnership, firm, association, or political subdivision of this State subject to municipal jurisdiction.

SECTION 2. That Article I "In General", Section 19-6, "Deposit of litter, garbage, etc., on public or private property" be hereby amended as follows:

Delete:

No person shall litter, sweep, lay or throw or permit his employee or any other person under his control to litter, sweep, lay or throw any ashes, dirt, garbage, refuse or rubbish of any kind in or upon any street, public place, lot, airshaft, areaway, back yard, basement, parking lot, court or alley. However, clean ashes or sand may be placed upon ice which has formed upon any sidewalk or duly designated parking area.

Add:

No person shall litter, sweep, lay or throw or permit his employees or any other person under his control to litter of any nature or upon any public or private property other than in a litter receptacle, or having done so, to allow such litter to remain. However, clean ashes, sand, or material specifically manufactured to melt ice may be placed upon ice which has formed upon any sidewalk or duly designated parking area.

SECTION 3. That all ordinances or parts of ordinances contrary to or inconsistent with this ordinance are hereby superseded.

SECTION 4. That if any section of this ordinance be adjudged invalid or unconstitutional, the same shall not affect the validity of the ordinance as a whole or any other section or provision hereby.

SECTION 5. This ordinance shall take the effect immediately upon passage and publication, or otherwise as provided by law.
